Current Rule/Policy:

There is no current rule of policy supporting contract between USASF gym members and their USASF member athletes.

New Rule/Suggestion of Change:

Once a USASF Athlete Member has signed a contract with a USASF member gym, they may not transfer to another USASF gym for the remainder of the USASF currently defined season/or once their USASF gym members season has been concluded, whichever comes first.

Exception: USASF Gym Owners may sign a written release allowing their USASF Gym Member to compete with another USASF Gym.

Perceived Benefit from New Rule/Suggestion of Change:

Athletes, clients and gym owners have engaged in poaching of talented athletes at the expense of one gym to benefit another. This proposed rule will define unethical standings directly related to this behavior and set the standard of professionalism while promoting and protecting USASF gym members.
