<b>New Rule/Suggestion of Change:</b>	<p><i>At all USASF Sanctioned Events, recruiting is prohibited by USASF gym owners, their employees or their clients.</i></p> <p><i>The specific rule: The USASF does not allow gym owners, their employees, and their clients to recruit other gym owners, their employees or their clients while attending any USASF Sanctioned Event. Recruiting would include physically approaching them and/or handing out any type of advertisement (for example but not limited to business cards, brochures, flyers on cars, etc.)</i></p>

<b>Perceived Benefit from New Rule/Suggestion of Change:</b>	<p><i>This rule would promote a safe zone at all USASF Sanctioned Events. This proposal also requests that clear guidelines are established and included in all registration documentation. Event Producers would be kept accountable for not providing the registration documentation and gym owners would be held accountable for violating USASF policy.</i></p> <p><i>We have reached a point in the development of our industry where we (the USASF) must honor and protect the integrity of our industry by valuing the gym owner and their contract with their athlete. This policy clearly defines that if you attend a USASF Sanctioned event you can be assured that your athletes will not be approached in any manner by other attendees. Many gyms would perceive this as an incentive to attend events that enforced the "No Recruiting Zone" policy. A logo could also be used for marketing purposed on all USASF Sanctioned Event Forms that promotes the fact that the event is a "No Recruiting Zone".</i></p>
