

USASF Disciplinary Action 2015-2016 Disclosure Summary:

During the 2015-2016 season, the Disciplinary Sub Review Committee reviewed 29 cases filed by USASF Members for Non-Compliance.

Below is a complete list of the charges and the penalties. Please note that all fines assessed are made payable to the USASF Scholarship Fund. The total fines assessed for Non-Compliance for the 2015-2016 season was \$31,000. Failure to pay assessed fines results in revocation of membership.
